Information only: Senator Dodd's office is reaching out to Yolo County as to the disposition of the funding promised to RCD for wildfire resilience.

Judith and Wyatt attended an informational meeting with SCI consulting who will handle the study for a potential Benefit Assessment Tax . If passed, FPD Board can review and adjust the amounts levied each year up to the amount approved by the voters. Mark asks if there is 172 funding on the table for districts who pass a 218 assessment, but there have been no commitments made by the County on this subject.

#### **Old Business:**

1. Update on Proposition 172 funding / Joint Operations Agreement

Judith and Wyatt attended the recent LAFCO meeting to discuss the Fire Protection District MSR. Commissioners Sandy and Saylor were absent and the vote on adoption of the MSR was deferred to the July 28 meeting. East Davis and Elkhorn were vocally resistant to the conclusions of the report. Judith reports that Christine mischaracterized us as being in negotiations with Madison on inclusion in the JOA though Madison has not approached the Capay Valley FPD Board of Commissioners on the issue.

CVERA core group met on July 4 to discuss trigger points for activating volunteers. An additional training for the volunteers will be held on 7/31 which will involve an exercise simulating a CVERA volunteer activation.

## 4. Discussion on Reserve Program

Craig confirms that his nephew is interested in a reserve program and we hope to be able to provide the opportunity. Jesse will talk to Curtis again about a shared reserve program between Capay Valley and Esparto.

### 7. FY 23 Budget (voting item)

Jesse presented the new budget draft as well as a report showing actual purchases for FY22 compared to the FY22 budgeted amount. CVFPD came in under budget on total expenses and over budget on total income for FY22. The Board increased the regular wages line item by \$1,800 to accommodate a 6% raise for Jesse's hourly admin/maintenance work – raise to go into effect on the current pay period.

Craig led an extrication training for the volunteers recently with a donated car. Jesse wants to work on a recruitment push as volunteer roster is down around 16. The new water tender has been delivered, needs hose/tools/decals/insurance before going in service.
