### **Old Business:**

### 1. Financial Sustainability (JOA/172/218)

Mark reported on the 2x2x2 meeting with Barry Burns and Rudy Lucero from Esparto, Mark Burns and Judith Redmond from Capay Valley, and Tim Schimmel and Kevin Crerar from Madison. The meeting was a good exchange of information with the Madison board members, who will take it back to the full Madison board. A date has not been set for another meeting.

SCI consulting released a draft fee analysis for a potential Benefit Assessment Tax. Jesse to meet with the consultants regarding methodology with the hope of reducing the fees, to find out about availability of voter polling, to find out about Board discretion in adjusting the actual fees assessed each year. Jesse will schedule meeting and up to two representatives of the Board will attend.

Board of Supervisors met regarding disbursal of the \$550,000 allocated for the fire districts and approved the working group recommendations though they may require commitment from departments to brining a BAT to the voters as a condition of eligibility.

Mike McDonald requests that the Benefit Assessment Tax be listed as a separate line item on the agenda with a more descriptive name for clarity.

Judith reports no activity on Rd. 41 though a tree is down on the roadway

3. Updates on the formation of the Capay Valley Emergency Response Auxiliary (CVERA) CVERA to honor Debbie Carson at her memorial, trainings to resume in January.

Began purchasing wildland PPE for 2023, much of which is covered by Cal Fire at 50% match Brush 222 back in service after annual maintenance, ladder testing completed, replaced control unit, wiring, and speaker for code 3's on E22 after initial repair was unsuccessful.

CVFPD to provide barn space for Brush 19, Jesse and Chief Lawrence to discuss using this as a shared reserve.

Firefighter Max McGregor began part-time work on 12/1/2022 and is working out very well Final week of training for CVFD in 2022, coming back in January

Jesse presented the call reporting from November 2022 and explained the format, focusing in on turnout times and drive times
