1. Update on Proposition 172 funding / Neighboring JOA Document
Wyatt reports that SCI submitted bid for county-wide 218 assessment at a rough cost of \$11,000\$13,000 per department to be paid out of Yolo general fund monies. If all of the \$300,000 general
fund money set aside for assessment is not used, there is a possibility of adding it to the \$500,000 set
aside for FD improvements.

7. LAFCO MSR

Mike reports that he has been attending all of the LAFCO meetings with Yolo County Fire Districts and that there seem to be some misconceptions in the County as to how the JOA works and what it does.
